Introduction

Launched in July 2023, the Wales Wildfire Board, an evolution of the All-Wales Strategic Arson Reduction Board, has been established to design, develop and implement a renewed approach to dealing with the impact of wildfires across Wales.

Through the provision of a Wales Wildfire Charter, formulated around three key themes designed to ensure the Board can focus on the areas which not only require the most attention but will also have the biggest influence in improving its understanding of wildfires, agencies will consider their approach to the prevention of wildfire and protection of communities and environments to implement a robust and consistent approach to wildfire risk management across Wales.

Burn to Protect Campaign

As part of its Wales Wildfire Charter, the Wales Wildfire Board and its partners commit to delivering a one-voice approach to wildfire messaging, awareness and education across Wales.

To support this, communication representatives, led by Mid and West Wales Fire and Rescue Service, evaluated the successes of communication and engagement associated with the All-Wales Strategic Arson Reduction Board, considered input from partner agencies and community representatives and developed the Burn to Protect Campaign.

One of two campaigns that are being driven by the Wales Wildfire Board, the overall objective of the Burn to Protect campaign is to develop a shared understanding of and a consistent, community and environmentally focussed approach to the wildfire problem in Wales with a particular focus on farmers and landowners.

Recognising that fire has been part of the natural ecology of upland and some lowland environments for many thousands of years and that it is also one of the oldest land-management tools, used for agriculture, game management and, more recently, wildlife conservation management, the Burn to Protect campaigns encourages farmers and landowners to work in collaboration with their local Fire Service, National Resources Wales and Unions to ensure they are burning responsibly and safely, in line with the [Heather and Grass Burning Code](#).



Our Communication Approach

This document sets out the agreed communications approach for the Wales Wildfire Board's Burn to Protect campaign, including target audiences and key messages, as agreed by all agencies involved in the multi-agency campaign.

It is intended that the communications messages will emphasise:

- Proactive and collaborative education.
- Diversionary and enforcement activities.
- A shared understanding of the importance of burning land responsibly in line with respective legislation.
- The importance of implementing effective wildfire prevention strategies when burning land.
- The part stakeholders can play in safeguarding our communities from the devastating impacts of wildfires.

The communications approach will be coordinated and monitored through the Wales Wildfire Board, its associated practitioner groups and where required, weekly Operational Dawns Glaw telephone conferences.

Our Commitments

Mid and West Wales Fire and Rescue Service Communications Team has developed a campaigns page on its Service website [#BurntoProtect](#) which holds all the materials developed to support the Burn to Protect campaign, including pre-written and pre-translated social media messages and downloadable social media graphics, for your ease of access.

Mid and West Wales Fire and Rescue Service Communications Team will also provide representation at the various groups associated with the Wales Wildfire Board, updating all agencies on any developments of note, including any changes to the media and communications approach.



All agencies are asked to send copies of all proactive communications activity to the Mid and West Wales Fire and Rescue Service Press Desk (pressofficer@mawwfire.gov.uk) so that an activity log may be coordinated.

All agencies are also asked to ensure that the Chair of the Wales Wildfire Board is made aware of any approaches for media interviews. You can do this by notifying Mid and West Wales Fire and Rescue Service's Press Desk by emailing pressofficer@mawwfire.gov.uk.

Localised media and communications approaches will be coordinated by each of the partners on the Wales Wildfire Board, to ensure local issues are addressed and highlighted as appropriate, whilst aligning any messaging to the wider aims, objectives and communications approaches of the Board.

All agencies are encouraged to share any publicity materials they have prepared in support of the Wales Wildfire Board activities as outlined in its Wildfire Charter. Again, this material will be shared on the campaign's webpage and will be coordinated by Mid and West Wales Fire and Rescue Service's Communications Team.

Our Aims

Communications activity will promote all aspects of the operation as required, inclusive of:

- Supporting engagement with farmers and landowners to highlight the value of working collaboratively with the Wales Wildfire Board and its partners to maintain and manage land responsibly to minimise the impact of wildfires. Additionally, this will consider the risks involved with setting fires to large areas of open ground and re-iterate the requirements from Welsh Government on grass and bracken burning regulations.





- Supporting engagement with tourism agencies across Wales to encourage responsible enjoyment of our countryside to reduce incidents of accidental fire setting.
- Supporting operational crews in educating members of the community about the most appropriate firefighting techniques used to deal with each incident – even where this means standing back and allowing the fire to burn – to reduce instances of re-ignition.
- Supporting the effects fires have on our wildlife and their habitats by circulating images of the effects of fire and drone footage.
- Supporting engagement with voluntary groups and users of the countryside to educate them on the consequences of fire setting, both deliberate and accidental, and engage them in intelligence gathering.





Our Audiences

- Landowners, Farmers, Land Managers and Commoners – controlled burn window, collaboration with respective agencies to maintain and manage land responsibly.
- Walking groups/users of the countryside – Report any concerns.
- Members of the public general awareness – accidental/deliberate/arson is a crime / our approach to firefighting / Play your part in protecting your communities, its inhabitants and their health, and the wider environment.
- RSPB / RSPCA / Wildlife organisations – having more of a voice in terms of deterrents and respecting your countryside and its wildlife.
- Police – arson is a crime/prosecutions/dispersal notice within areas of high activity.





Our Plan

- Collaborative Press Releases – One to be circulated at initiation and then on a reactive basis as and when required. To ensure consistency in terms of the message and statistics provided, please copy all press releases to pressofficer@mawwfire.gov.uk so that they can be added to the campaign webpage to be shared with the group for information.
- Case Studies – If individual organisations find an opportunity to highlight a specific case study in their area, then please proceed with publicising. Please also share with the Mid and West Wales Fire and Rescue Service press desk so that awareness can be raised across the Wales Wildfire Group.
- Radio adverts – The group proactively encourages the use of Radio advertising to promote the work of the Wales Wildfire Board and its key messages. Due to the nature of radio coverage, radio advertising can be organised at a local level, utilising the messages provided in this document.
- Key messages / social media messages – A central repository of preapproved/pre-translated messages is provided within the campaign page published on Mid and West Wales Fire and Service website [#BurntoProtect](#) along with associated downloadable social media graphics.





Our Key Messages

- Through an evolving partnership approach, we will bring together Welsh Government, Emergency Services, Public and Private Organisations, Landowners and Land Users to manage and develop our landscape.
- We will contribute to the management of our landscape to protect wildlife, forestry and livelihoods; improve well-being, health and amenity, facilitate sustainable food production and create a sense of place and community ownership.
- We will implement a diverse range of management techniques to reduce the impact of wildfire on our communities and the landscape in Wales.
- Every year fire is responsible for the destruction of thousands of hectares of countryside, open space and wildlife habitats.
- Partners of the Wales Wildfire Board commit to working with communities to build a healthier and more resilient landscape, by developing a more biodiverse countryside for the future.
- Drawing together a multi-agency approach to Wildfire awareness, the Wales Wildfire Board aims to engage with various audiences, working together to support wildfire management, listening and sharing practical solutions for Wales.
- Through a collaborative approach, agencies on the Wales Wildfire Board hope to provide a better understanding of what can be done to limit the number of wildfire fires, in turn, minimising the damage they can cause to our environment.
- All agencies on the Wales Wildfire Board want to understand and recognise each other's impacts and work together to develop effective early interventions for wildfires in Wales.





- To understand and recognise each other's impacts and develop a range of early interventions for wildfires in Wales, partners need to work collaboratively and communicate effectively.
- To deliver a one-voice approach to wildfire messaging, awareness, and education across Wales, it is essential to bring together all relevant stakeholders and work collaboratively.
- We recognise it is important to engage with communities and stakeholders across the region to build awareness, understanding, and support for wildfire risk management.
- Managing the number, scale, severity, and impact of wildfire incidents requires a comprehensive approach that focuses on prevention, early detection and rapid response.
- To adapt to nature and climate developments and restore connections to green space and community while reducing uncontrolled vegetation burning, it is important to take a multi-faceted approach that focuses on community engagement, land management, and climate-smart practices.
- To support cleaner air and protect natural and heritage resources while reducing the risk of wildfires, it is important to take a comprehensive approach that focuses on reducing emissions, promoting sustainable land use, and preserving natural and cultural resources.
- Protecting carbon sources in soil and woodlands is crucial for mitigating climate change and promoting carbon sequestration.
- Adopting a Landscape Management approach to Wildfire Risk Management involves a holistic approach to managing the land and reducing the risk of wildfires.





- Wildfire fires put lives in danger. It will take the Fire and Rescue Service longer to respond to life risk emergencies like house fires, or road traffic collisions if they are already tied up tackling a wildfire.
- By establishing a collaborative network, identifying knowledge gaps and training needs, developing appropriate training materials, and delivering training through various methods, stakeholders can work together to build their capacity and improve wildfire risk management practices in Wales.
- Sharing knowledge and best practices will help to strengthen collaboration, build trust, and promote a shared vision for wildfire risk management.
- By creating a multi-functional Fire Risk Map and a toolkit for preventative land management techniques, stakeholders can identify areas at high risk of wildfire and implement targeted land management strategies to reduce this risk. The map and toolkit can be used to inform land management decisions, target resources, and raise awareness of the importance of preventative measures in reducing the impact of wildfires in Wales.
- By sharing resources and implementing prevention measures, stakeholders on the Wales Wildfire Board can reduce the occurrence and severity of wildfires in Wales.
- A collaborative approach that involves all stakeholders can identify high-risk areas and develop effective strategies to prevent wildfires.
- Early warning systems can be used to respond quickly to potential wildfire risk, while awareness campaigns can help to raise public awareness of the importance of prevention measures.
- Wildfires are dangerous and unpredictable; they can quickly spread out of control.
- Wildfire smoke can affect your breathing, irritate your skin and eyes, and cause chest pains.





- Wildfires can severely damage our countryside and our environment.
- Wildfires destroy wildlife and livestock.
- Wildfires cost the Welsh economy millions of pounds each year.
- Smoke from wildfires is hazardous to health, in areas affected stay indoors and keep doors and windows closed.



Our Materials

#BurnToProtect Launch Press Release (English)

The Wales Wildfire Board are encouraging farmers and landowners to #BurnToProtect the Welsh countryside this burn season.

As the long, hot summer comes to an end and we transition into autumn, with dry vegetation and a reduction in temperatures, burn season officially gets underway.

The Wales Wildfire Board want to remind farmers and landowners that burning heather, grass, bracken, and gorse can take place from 1 October up until 15 March (up to 31 March in Upland areas), however, they must have a Burn Plan in place to ensure they are burning safely.

Andrew Wright, Chair of the Wales Wildfire Board and Senior Specialist Advisor - Plant Health and Knowledge Transfer at Natural Resources Wales said:

“2025 has seen an unprecedented spike in wildfires across Wales. Combining grassland, woodland, crop and wildfire blazes, the three Fire and Rescue Services have responded to a total of 3289 incidents since January 2025, the largest number of incidents since 2018.

“As land managers, you play a critical role in safeguarding our communities from the devastating impacts of wildfires. Your land and livelihood are not just vital to you but are also essential to our broader ecosystem and economy.

“We are urging you to implement effective wildfire prevention strategies when burning your land.

“Burning your land responsibly is crucial in protecting your assets, guaranteeing the safety of your family and maintaining the productivity of your land whilst also ensuring you respect our countryside and play your part in safeguarding our environment and keeping our communities safe.

“Many wildfires are preventable and there are some simple steps and changes to behaviour that can limit their number and impact.”

The Wales Wildfire Board are encouraging farmers and landowners to work in collaboration with their local Fire Service, National Resources Wales and Unions to ensure they are burning responsibly and safely.

As part of their [#BurntoProtect](#) Campaign, the Wales Wildfire Board are reminding landowners of some simple advice which will help support a responsible burn:

- Notify your local Fire and Rescue Service to avoid false alarms and crews being sent out unnecessarily as well as ensure we are ready to respond in the event of a burn getting out of control.
- Ensure you have sufficient people and equipment to control the fire.
- Check wind direction and ensure there is no risk to property, roads and wildlife.
- If a fire gets out of control, contact the fire service immediately giving details of the location and access.
- It is illegal to leave a fire unattended or to have too few people to control it.
- Always ensure a fire is completely out before you leave it and check the next day to ensure it has not reignited.

Mared Jones, Deputy Chair of the Wales Wildfire Board and Chief Executive Officer for the Welsh Federation of Young Farmers said:

“It is vitally important that we all continue to work together to build a healthier, more resilient and increasingly biodiverse landscape here in Wales, doing what we can to protect this precious resource for the future.

“We want to work with our farmers and landowners to share our knowledge and understanding of the effect that both deliberate and accidental fires have on our communities. We understand that controlled burns can have a positive effect on the environment, creating biodiversity and a sustainable ecosystem and we are available for free advice on how to do this safely”

By working together with communities to share knowledge, the Wales Wildfire Board hope to provide a better understanding of what we can all do to limit accidental fires from happening and in turn the damage they can cause to our environment.

Datganiad i'r Wasg Lansio #LlosgilAmddiffyn (Cymraeg)

Mae Bwrdd Tanau Gwylt Cymru yn annog ffermwyr a thirfeddianwyr i #LlosgilAmddiffyn cefn gwlad Cymru yn ystod y tymor llosgi.

Wrth i'r haf hir, poeth ddod i ben a'n bod ni'n symud i'r hydref, gyda llystyfiant sych a gostyngiad mewn tymheredd, mae'r tymor llosgi yn dechrau yn swyddogol.

Mae Bwrdd Tanau Gwylt Cymru eisiau atgoffa ffermwyr a thirfeddianwyr y gall llosgi grug, glaswellt, rhedyn ac eithin ddigwydd o 1 Hydref hyd at 15 Mawrth (hyd at 31 Mawrth mewn ardaloedd Ucheldir), fodd bynnag, mae'n rhaid iddynt gael Cynllun Llosgi ar waith i sicrhau eu bod yn llosgi'n ddiogel.

Dywedodd Andrew Wright, Cadeirydd Bwrdd Tanau Gwylt Cymru ac Uwch Gynghorydd Arbenigol - Iechyd Planhigion a Throsglwyddo Gwybodaeth yn Cyfoeth Naturiol Cymru:

"Mae 2025 wedi gweld cynnydd digynsail mewn tanau gwylt ledled Cymru. Gan gyfuno tanau glaswelltir, coetir, cnydau a thanau gwylt, mae'r tri Gwasanaeth Tân ac Achub wedi ymateb i gyfanswm o 3289 o ddigwyddiadau ers mis Ionawr 2025, y nifer fwyaf o ddigwyddiadau ers 2018.
