## Introduction

Officially launched in July 2023, the Wales Wildfire Board, an evolution of the Strategic Arson Reduction Board, has been established to design, develop and implement a renewed approach to dealing with the impact of wildfires across Wales.

Through the provision of a Wales Wildfire Charter, formulated around three key themes designed to ensure the Board can focus on the areas which not only require the most attention but will also have the biggest influence in improving its understanding of wildfires, agencies will consider their approach to the prevention of wildfire and protection of communities and environments to implement a robust and consistent approach to wildfire risk management across Wales.

## Wildfire Wise Campaign

As part of its Wales Wildfire Charter, the Wales Wildfire Board and its partners commit to delivering a one-voice approach to wildfire messaging, awareness and education across Wales.

To support this, communication representatives, led by Mid and West Wales Fire and Rescue Service, evaluated the successes of communication and engagement associated with the Strategic Arson Reduction Board, considered input from partner agencies and community representatives and developed the Wildfire Wise Campaign.

One of two campaigns that are being driven by the Wales Wildfire Board, the overall objective of the Wildfire Wise campaign is to develop a shared understanding of the wildfire problem in Wales, including the factors that contribute to wildfires, the potential impacts, the existing intervention, and the simple changes that can be made and behaviours that can be modified to safeguard our communities and the environment of Wales.





## Our Communication Approach

This document sets out the agreed communications approach for the Wales Wildfire Board's Wildfire Wise campaign, including target audiences and key messages, as agreed by all agencies involved in the multi-agency campaign.

It is intended that the communications messages will emphasise proactive and collaborative education, diversionary and enforcement activities and the part stakeholders across communities can play in reducing incidents of both deliberately set fires (arson) and accidentally set fires.

The communications approach will be coordinated and monitored through the Wales Wildfire Board, its associated practitioner groups and where required, weekly Operational Dawns Glaw telephone conferences.

## Our Commitments

Mid and West Wales Fire and Rescue Service Communications Team has developed a campaigns page on its Service website [#WildfireWise](#) which holds all the materials developed to support the Wildfire Wise campaign, including pre-written and pre-translated social media messages and downloadable social media graphics, for your ease of access.

Mid and West Wales Fire and Rescue Service Communications Team will also provide representation at the various groups associated with the Wales Wildfire Board, updating all agencies on any developments of note, including any changes to the media and communications approach.

All agencies are asked to send copies of all proactive communications activity to the Mid and West Wales Fire and Rescue Service Press Desk ([pressofficer@mawwfire.gov.uk](mailto:pressofficer@mawwfire.gov.uk)) so that an activity log may be coordinated.

All agencies are also asked to ensure that the Chair of the Wales Wildfire Board is made aware of any approaches for media interviews. You can do this by notifying

Localised media and communications approaches will be coordinated by each of the partners on the Wales Wildfire Board, to ensure local issues are addressed and highlighted as appropriate, whilst aligning any messaging to the wider aims, objectives and communications approaches of the Board.

All agencies are encouraged to share any publicity materials they have prepared in support of the Wales Wildfire Board activities as outlined in its Wildfire Charter. Again, this material will be shared on the campaign's webpage and will be coordinated by Mid and West Wales Fire and Rescue Service Communications Team.

## **Our Aims**

Communications activity will promote all aspects of the operation as required, inclusive of:

- Supporting all initiatives developed to engage with those involved in fire setting to prevent the activity – including supporting diversionary activities developed to engage with disaffected individuals to break down barriers between them and the emergency services.
- Supporting school liaison teams at schools and youth clubs – including fire cadet activities.
- Supporting high visibility patrols within high activity areas.
- Supporting engagement with voluntary groups and users of the countryside to educate them on the consequences of fire setting, both deliberate and accidental, and engage them in intelligence gathering.
- Supporting engagement with landowners and commoners to highlight the value of working collaboratively with the Wales Wildfire Board and its partners to maintain and manage land responsibly to minimise the impact of wildfires. Additionally, this will consider the risks involved with setting fires to large





areas of open ground and re-iterate the requirements from Welsh Government on grass and bracken burning regulations.

- Supporting engagement with tourism agencies across Wales to encourage responsible enjoyment of our countryside to reduce incidents of accidental fire setting.
- Supporting operational crews in educating members of the community about the most appropriate firefighting techniques used to deal with each incident – even where this means standing back and allowing the fire to burn – to reduce instances of re-ignition.
- Supporting the effects fires have on our wildlife and their habitats by circulating images of the effects of fire and drone footage.





## Our Audiences

- Landowners, Farmers, Land Managers and Commoners – controlled burn window, collaboration with respective agencies to maintain and manage land responsibly.
- Young people – summer safety messaging and arson messages.
- Walking groups / users of the countryside – summer safety messaging and report any concerns.
- Tourists / those enjoying the countryside – Summer safety messaging and encouraging individuals to respect our countryside.
- Members of the public general awareness – accidental / deliberate / arson is a crime / our approach to firefighting / Play your part in protecting your communities, its inhabitants and their health, and the wider environment.
- RSPB / RSPCA / Wildlife organisations – having more of a voice in terms of deterrents and respecting your countryside and its wildlife.
- Police – arson is a crime/prosecutions / dispersal notice within areas of high activity.







## Our Plan

- Radio adverts – The group proactively encourages the use of Radio advertising to promote the work of the Wales Wildfire Board and its key messages. Due to the nature of radio coverage, radio advertising can be organised at a local level, utilising the messages provided in this document.

## Our Key Messages

- Through an evolving partnership approach, we will bring together Welsh Government, Emergency Services, Public and Private Organisations, Landowners and Land Users to manage and develop our landscape.
- We will contribute to the management of our landscape to protect wildlife, forestry and livelihoods; improve well-being, health and amenity, facilitate sustainable food production and create a sense of place and community ownership.
- We will implement a diverse range of management techniques to reduce the impact of wildfire on our communities and the landscape in Wales.
- Every year fire is responsible for the destruction of thousands of hectares of countryside, open space and wildlife habitats.
- Partners of the Wales Wildfire Board commit to working with communities to build a healthier and more resilient landscape, by developing a more biodiverse countryside for the future.
- Drawing together a multi-agency approach to Wildfire awareness, the Wales Wildfire Board aims to engage with various audiences, working together to support wildfire management, listening and sharing practical solutions for Wales.
- Through a collaborative approach, agencies on the Wales Wildfire Board hope to provide a better understanding of what can be done to limit the number of wildfire fires, in turn, minimising the damage they can cause to our environment.
- All agencies on the Wales Wildfire Board want to understand and recognise each other's impacts and work together to develop effective early interventions for wildfires in Wales.
- To understand and recognise each other's impacts and develop a range of early interventions for wildfires in Wales, it is important for partners to work collaboratively and communicate effectively.





- To deliver a one-voice approach to wildfire messaging, awareness, and education across Wales, it is essential to bring together all relevant stakeholders and work collaboratively.
- We recognise it is important to engage with communities and stakeholders across the region to build awareness, understanding, and support for wildfire risk management.
- Managing the number, scale, severity, and impact of wildfire incidents requires a comprehensive approach that focuses on prevention, early detection and rapid response.
- To adapt to nature and climate developments and restore connections to green space and community while reducing uncontrolled vegetation burning, it is important to take a multi-faceted approach that focuses on community engagement, land management, and climate-smart practices.
- To support cleaner air and protect natural and heritage resources while reducing the risk of wildfires, it is important to take a comprehensive approach that focuses on reducing emissions, promoting sustainable land use, and preserving natural and cultural resources.
- Protecting carbon sources in soil and woodlands is crucial for mitigating climate change and promoting carbon sequestration.
- Adopting a Landscape Management approach to Wildfire Risk Management involves a holistic approach to managing the land and reducing the risk of wildfires.
- Wildfire fires put lives in danger. It will take the Fire and Rescue Service longer to respond to life risk emergencies like house fires, or road traffic collisions if they are already tied up tackling a wildfire.
- By establishing a collaborative network, identifying knowledge gaps and training needs, developing appropriate training materials, and delivering training through various methods, stakeholders can work together to build their capacity and improve wildfire risk management practices in Wales.





- Sharing knowledge and best practices will help to strengthen collaboration, build trust, and promote a shared vision for wildfire risk management.
- By creating a multi-functional Fire Risk Map and a toolkit for preventative land management techniques, stakeholders can identify areas at high risk of wildfire and implement targeted land management strategies to reduce this risk. The map and toolkit can be used to inform land management decisions, target resources, and raise awareness of the importance of preventative measures in reducing the impact of wildfires in Wales.
- By sharing resources and implementing prevention measures, stakeholders on the Wales Wildfire Board can reduce the occurrence and severity of wildfires in Wales.
- A collaborative approach that involves all stakeholders can identify high-risk areas and develop effective strategies to prevent wildfires.
- Early warning systems can be used to respond quickly to potential wildfire risk, while awareness campaigns can help to raise public awareness of the importance of prevention measures.
- Wildfires are dangerous and unpredictable; they can quickly spread out of control.
- Wildfire smoke can affect your breathing, irritate your skin and eyes, and cause chest pains.
- Wildfires can severely damage our countryside and our environment.
- Wildfires destroy wildlife and livestock.
- Wildfires cost the Welsh economy millions of pounds each year.
- Smoke from wildfires is hazardous to health, in areas affected stay indoors and keep doors and windows closed.





## Our Materials

### #WildfireWise Launch Press Release (English)

The Wales Wildfire Board are encouraging you to be #wildfirewise this spring and summer.

As the seasons change, and the promise of warmer weather is on the horizon, it is the ideal time to enjoy a variety of outdoor activities, book your staycations or holidays, take your family on a camping trip, or just enjoy your local area.

The Spring and Summer months carry with them a real set of dangers if you do not follow practical and correct safety advice appropriate for this time of year. The Wales Wildfire Board are encouraging everyone to be Wildfire Wise and commit to simple precautions and a little extra care will ensure we can continue to enjoy our beautiful countryside and keep our communities safe from the devastating effects of wildfire.

During this time of year, grass and mountains can become very dry, which means if you deliberately or accidentally start a fire outdoors it will spread very quickly, destroying everything in its path.

In 2024 fire services across Wales attended 977 grassfire incidents – this was a decrease of 47% on the previous year with deliberate grass fires decreasing by 576 (44%) to 713.

The Wales Wildfire Board want to work with communities to build a healthier and more resilient countryside and to develop a more biodiverse countryside for the future.

Our #WildfireWise campaign aims to educate individuals on the best practices for avoiding and preventing wildfires in Wales.

By raising awareness about the potential dangers of wildfires, the campaign will encourage people to be more vigilant when out enjoying the countryside and proactive in reporting suspicious activities that can lead to fires.

Many wildfires are preventable and there are some simple steps and changes to behaviour that can limit their number and impact.

**Andrew Wright, new Chair of the Wales Wildfire Board and Senior Specialist Advisor - Plant Health and Knowledge Transfer at Natural Resources Wales said:**

“Our Wildfire Wise campaign is built on the knowledge and experience partners on the Board have gained over the last decade in dealing with the impact of wildfires across Wales.





“We are encouraging all members of our communities to respect our countryside and play their part in safeguarding our environment and keeping our communities safe.

“It is vitally important that we all continue to work together to build a healthier, more resilient and increasingly biodiverse landscape here in Wales, doing what we can to protect this precious resource for the future.

“While accidents do happen, they are also avoidable, and our Wildfire Wise campaign focuses on educating us all on some of the small steps we can take to ensure we don’t accidentally cause a grass fire to ignite.

“We want to work with our communities, farmers, and landowners to share our knowledge and understanding of the effect that both deliberate and accidental fires have on our communities. We understand that controlled burns can have a positive effect on the environment, creating biodiversity and a sustainable ecosystem and we are available for free advice on how to do this safely.”

“We would also like to take the opportunity to reinforce our messages that while accidents can happen, there are others within our communities who are deliberately setting fire to our countryside – not only is this a crime, for which they will be prosecuted, but it also places unnecessary pressure on front line services and puts our communities in harm’s way.”

By working together with our communities to share our knowledge, the Wales Wildfire Board hope to provide a better understanding of what we can all do to limit accidental fires from happening and in turn the damage they can cause to our environment.
